I just received a call from P01 who is the mother of a child attending Nurture One daycare in Holt. Key points:

- P01 and father of child are separated (but on good terms)
- There is a staff member named P01 who engaged in a relationship with the father. Which then went sour and P01 over the [REDACTED]

- P01 spoke to the facility today and informed them of the criminal activity and said she is not comfortable P01 working there anymore.
- Facility said that the only option is for P01 to remove her child as P01 is continuing to work there. P01 does not want to remove child as she is settled and has friendships there.
- Facility then said if she wishes to keep her child there she cannot speak to P01.
- P01 believes P01 should not be working around kids while she is facing charges and feels that it may negatively impact her child.

Her number is P03. Could you please get the appropriate regulatory officer to give her a call ASAP.
