Christ Steel MLA took on notice the following question(s):

MR EMERSON: Yes, we have almost come full circle talking about election commitments again, but I am just asking if you can take on notice a list of the Labor election commitments that were costed by Treasury in 2024 going into the election and have not yet been fully funded, and the total costs of these as yet unfunded commitments based on those pre-election costings.

Mr Steel: So they are already published. So I am happy to point you towards the publishings. I will take that on notice and point you towards the published information. The budgets that we have outlined, the first two budgets of the year, and the election costings that we have made, and the updates on the delivery of our election commitments that we are also transparently reporting.

THE CHAIR: So confirming you are taking that on notice?

Mr Steel: Yes.
