Reference: Hearing on 10 November, Annual Report of Minister for the Arts

In relation to: Cultural Facilities Corporation – Sylvia Curley Memorial Education Centre

1. Please advise the current venue hire rates for the Sylvia Curley Memorial Education Centre at Mugga-Mugga Cottage, including different seasonal, weekday or weekend rates.

- 2. Please advise the current rates for any additional services or equipment available for hire at the Sylvia Curley Memorial Education Centre at Mugga-Mugga Cottage.
- 3. On how many occasions has the Sylvia Curley Memorial Education Centre at Mugga-Mugga Cottage been hired out in calendar year 2022 to date?
 - a. Please advise how many weekdays, in calendar year 2022 to date, the venue was hired out, and the rate for each of those occasions.
 - b. Please advise how many Saturdays, in calendar year 2022 to date, the venue was hired out, and the rate for each of those occasions.
 - c. Please advise how many Sundays, in calendar year 2022 to date, the venue was hired out, and the rate for each of those occasions.
 - d. Please advise whether the venue was hired on Saturday 1 October 2022 by the CEO's chief of staff, the rate for that hire if it occurred when payment/s were made, and whether any discount was applied when determining the hire rate.
 - Please advise whether any additional services or equipment were hired on Saturday 1
 October 2022 by the CEO's chief of staff, when payment/s were made, and the rate for
 that hire if it occurred.

Tara Cheyne MLA: The answer to the Member's question is as follows:-

The Cultural Facilities Corporation (CFC), an independent body with a governing board, advises:

- 1. The current venue hire rate for the Sylvia Curley Memorial Education Centre at Mugga-Mugga Cottage is \$300. An additional \$150.00 charge is applied for late departures and out of hours venue hire, including weekends. There is no seasonal variation to the hire rate.
- 2. The current rates for additional services and equipment available are:

Mugga-Mugga Equipment Required for Hire	Hire Fee
Barbeque	\$30.00
Lectern	Inc in venue hire charges
Tables (trestle); Education Centre venue hire ONLY	Inc in venue hire charges
Chairs; Education Centre venue hire ONLY	Inc in venue hire charges
Table cloths; Education Centre venue hire ONLY	Inc in venue hire charges
Crockery, Glassware and Cutlery; Education Centre venue hire ONLY	Inc in venue hire charges

- 3. The Sylvia Curley Memorial Education Centre at Mugga-Mugga Cottage has been hired out once in 2022.
 - a. The Sylvia Curley Memorial Education Centre at Mugga-Mugga Cottage has not been hired on a Weekday in 2022.
 - b. The Sylvia Curley Memorial Education Centre at Mugga-Mugga Cottage has been hired on one Saturday in 2022. The hire rate on this occasion was \$450.
 - c. The Sylvia Curley Memorial Education Centre at Mugga-Mugga Cottage has not been hired on a Sunday in 2022.
 - d. The CFC is unable to disclose the identity of specific venue hirers as this would be a potential breach of the Information Privacy Act. The CFC can confirm that the venue was hired for a private function on Saturday 1 October 2022 at a rate of \$450. Payment was received in full by the CFC on 7 September 2022. No discounts were applied to the hire rate.
 - e. The CFC is unable to disclose the identity of specific venue hirers as this would be a potential breach of the Information Privacy Act. The CFC can confirm that no additional services or equipment have been hired for Sylvia Curley Memorial Education Centre venue hires in 2022.
