Response to questions 1-5

1063 development applications (DA) were lodged with the independent planning and land authority (the Authority) during the 2021-2022 financial year.

The following table provides the timeframes for determination of applications lodged in the 2021-22 financial year.

*83 DAs lodged in the 2021-22 financial year are yet to be determined or waiting for further information. This includes all applications lodged up until 30 June 2022.

Response to questions 6-7

There are three types of environmental assessments available for protected matters in the ACT:

- Environmental Impact Statement (EIS);
- EIS exemption; and
- Environmental Significance Opinion (ESO).

The suitability of each assessment depends on the circumstances of a proposed development. A DA is not always required once the environmental assessment process has been completed.

Proposals that trigger the requirement for an EIS or have been granted an EIS exemption must be followed by the submission of a DA in the impact track.

However, for some proposals an ESO may be given by a relevant entity (the Conservator of Flora and Fauna, the Heritage Council or the Authority) that the proposal is not likely to have a significant adverse environmental or heritage impact. Where an ESO has been given, the proponent can then submit a merit track DA or consider the exemptions from the requirement for development approval available under Schedule 1 of the *Planning and Development Regulation 2008*.

The table below provides a breakdown of environmental assessments that were completed in 2018-19, 2019-20, 2020-21 and 2021-22.

Response to question 11 - 12

In accordance with section 149 and 150 of the Planning and Development Act 2007 (the Act), an entity must give the planning and land authority (the Authority) advice in relation to the development application (DA) no later than 15 working days. If an entity fails to provide advice in relation to a DA referred to the entity, the entity is taken to have given advice that the entity supports the application.

The Authority does not have statistics on DAs that have been deemed supported by ACT Heritage in accordance with section 149 and 150 of the Act. Generally, a DA that has been referred to ACT Heritage for comment will not be decided by the Authority until comments are received.

Response to question 13

The processing of environmental assessments (EISs, EIS exemptions and ESOs) is a statutory function performed by the independent planning and land authority. The team responsible for these assessments comprise 7 FTEs and has been unchanged since 2018.

The team responsible for processing of environmental assessments has additional responsibilities such as associated environmental reporting, and sometimes draw on expertise from other teams within the independent planning and land authority, EPSDD and other parts of Government.
