In relation to:

Number of CSD staff who have undergone cultural competency training

MINISTER STEPHEN-SMITH: The answer to the Member's question is as follows:-

Currently, CSD delivers six (6) training programs to staff on cultural competency, delivered via both eLearn and face-to-face learning.

The cultural competency training is identified as core learning across the Directorate for staff up to a team leader/supervisor or ASO6 and the equivalent Child and Youth Protection Professional (CYPP) classifications. The cultural competency training does not currently require refresher training following the initial completion.

The eLearn training packages are procured by the ACT Government through recognised Aboriginal and Torres Strait Islander or cultural organisations, Special Broadcasting Service (SBS) and the Australian Institute of Aboriginal and Torres Strait Islander Studies (AIATSIS). The face-to-face training is developed and delivered by the CSD cultural training officer to officers in Child and Youth Protection Services (CYPS).

Table 1 contains a breakdown of cultural competency training programs, modules and number of CSD staff who have completed the module during the 2021-22 financial year. Note that this does not reflect the total number of staff who have completed the training before the 2021-22 financial year. This data would require manual extraction and this is considered an unreasonable diversion of resources.

The Directorate's Learning Management System delivers monthly reminders to employees and their managers of the requirement to complete the training. These reminders are sent until such time as completion is achieved.
