Wanted to speak about P01 a staff member and P01 explained he no longer worked at St Nicks. They mentioned that they didn't have any concerns if he was no longer working at St Nicks but would have questions if he was still employed at St Nicks. P01 explained the history around a 2018 complaint/allegation of sexual abuse and then police involvement in an investigation more recently which we were given no information nor told what the allegations were. CYPS mentioned that they are following up from the Police report and that we didn't need to do anything but they would put this information forward to CECA and WWVP. CECA sent us the information which was provided to them by CYPS. Information of the allegation is attached. It is a redacted file so much of it is blacked out. I also sent an email to P01 on 15/11/23 providing correspondence, documents and a timeline regarding the situation with P01 and the police investigation.
