Time 8.30am **P01 P01** (parent of child enrolled at the service - **P01 P01**) came to **P01 P01** (educator) this morning and asked if we (educators in her child's room) could keep a second set of eyes on **P01** (child) today as she made some unusual comments on Friday night.

P01 said she had been touched on the vagina and bum. **P01** also asked **P01** what happened next and she said They sucked blood out of my vagina."

P01 said - "They (family of **P01**) went to the police and they couldn't do anything as **P01** hasn't disclosed anything to them. Police then made a referral to Sexual assault and child abuse team. They called her Saturday morning.

They attended the Belconnen Winchester centre They gave info and interview **P01** She hadn't disclosed anything to them. From their perspective not much they could do."

P01 did not disclose where the incident occurred or with whom . **P01** did not wish to discuss with the educators .

The service NS (**P01 P01**) has reached out to the parent to follow up in order to support her and and **P01** at this time ,to which mum has agreed to meet with **P01** at the service on 17.10.23.

P01 attended the service as normal and no sign of abnormal behaviours during the day.
