Funding for services supporting vulnerable young people: Youth Engagement and Family Support for Youth – really welcome this initiative but concerned about ensuring that how the funding is rolled out meets the intent of the Parliamentary Agreement and responds to the evidence base regarding Youth Engagement. The Youth Coalition also highlights concern that the new initiatives, when viewed in the context of savings (cuts to services) that vulnerable young

people will need additional support. Further, funding for Diversity ACT has been identified in this funding stream, while we support funding for this service we understand it is not necessarily funding to provide a youth specific service.

Early Intervention and Prevention - The Youth Coalition welcomes the Intervention Services initiative but notes that a shared agency funding and a whole of government approach to early intervention and prevention services has not been adopted in this Budget.

Education support for young people at risk of not engaging with education – cuts to services noted in the first point include cuts to education support for young people in the Care & Protection and Youth Justice system. While we support Education and Training Directorate picking up responsibility for ensuring educational engagement support for all young people as core business, we remain concerned about capacity within the system to just do this without additional resources. This is an example where we would like to see some joint agency statement, as we lose the service how this will specifically be addressed.

Budget Analysis Overview

The Youth Coalition of the ACT, the peak body for youth affairs, acknowledges the challenges faced by the ACT Government in developing the ACT Budget 2013 / 14, and welcomes the announcement of funding for some key initiatives.

While the promising spending initiatives are welcomed, much of the detail is still to come. It is essential the ACT Government develop services in an informed way, utilising the evidence about what is needed and what works in providing key supports to young members of our community. The Youth Coalition calls on the ACT Government to include the views of young people and frontline community service workers in identifying the best ways in which these resources can be utilised moving forward.

The ACT Budget 2013 / 14 contains a number of promising gains for young people, in particular that the ACT Government's election commitment to additional funding for youth engagement services has been realised. The Budget also recognises the ACT sign on to the National Plan for School Improvement (Gonski reforms), increases funding for community based mental health services, and invests in the establishment of a Trauma Recovery and Research Centre.

The Youth Coalition highlights concern however that the new initiatives, when viewed in the context of savings (cuts to services), indicate that the ACT Government is still far from approaching the provision of services and supports for young people and their families in a 'whole of government' planned way.

The Youth Coalition's 2013 /14 ACT Budget Analysis provides a summary of and comment on the initiatives that will have most impact on young people and youth services in the ACT community.

Consideration of the 2012 election commitments and the commitments under the ACT Greens / ACT Labor Parliamentary Agreement (the Parliamentary Agreement) has been included in providing comment and analysis of the Budget.

Key Priorities that the Youth Coalition identified in its submission to the 2013 / 14 ACT Budget were:

- Early Intervention and Prevention
- Youth Services
- Education
- Housing and Homelessness
- Health, particularly Mental Health
- Young People and the Law
- Transport and Planning
- Workforce Development and Community Sector

Some of the key initiatives and commitments of the 2013 / 14 ACT Budget in these areas are outlined below. A more comprehensive list of initiatives and analysis is provided under each ACT Government Directorate in *Part 2: Expenditure and Capital Works*.

Early Intervention and Prevention

Addressing the root causes of social disadvantage and vulnerability is a clear policy goal, both locally and nationally, and a common desire in the community service sector. The need for intervention with young people early in the life of any problem, as well as the life of the young person, is clearly articulated in the National Youth Strategy, 2010.¹

The Youth Coalition submission to the 2013 / 14 ACT Budget called for the ACT Government to lead the development of an early intervention and prevention framework that encompasses a whole of government approach to strategies and funding, and engages the broader community including the child, youth, family support, health and education sectors.

While shared agency funding and a whole of government approach to early intervention and prevention services has not been adopted in this Budget initiatives announced for 2013 / 14 ACT included:

- Intervention Services – establishment of a Trauma Recovery and Research Centre

The Youth Coalition welcomes this initiative, which acknowledges therapeutic services are an essential component of a service system that seeks to address the support needs of vulnerable young people and their families.

Youth Services

The Youth Coalition submission to the 2013 / 14 ACT Budget identified youth engagement and therapeutic services as key priorities for investment in services for young people.

The Youth Coalition congratulates the ACT Government in delivering investment in both these areas, which also work towards meeting commitments under the Parliamentary Agreement.

Therapeutic Services for Young People

While the establishment of the Trauma Recovery and Research Centre (discussed in the previous section) is very welcome, the Youth Coalition notes that member agencies have reported unmet demand for community based therapeutic services and programs for young people also.

Youth Engagement

The funding committed under *Youth Engagement and Family Support for Youth* of \$1.13 million in 2013/14 (\$4.93 million over the next 4 years) has been identified to support the following:

- Existing Youth Engagement Services under the Children Youth and Family Services Program;

The Youth Coalition congratulates the ACT Government in listening to the call from young people and the community to re-invest in youth engagement services. It is essential to see this money bolster existing services, which have seen a reduction in funding over the past 18 months. The Youth Coalition looks forward to working with the sector and the Community Services Directorate around the implementation of this and encourages the use of an evidence base, including the Youth Engagement Research Paper (soon to be released by the Youth Coalition and FACT) to inform the expenditure of these funds.

- Funding for a community based transitions worker;

The Youth Coalition welcomes this initiative that partially meets the Parliamentary Agreement to fund a community based service for young people transitioning from care.

- Diversity ACT

The Youth Coalition welcomes initiatives providing additional support to LGBTI communities. We note however that this funding to Diversity ACT is not youth specific.

While it is great to see this injection of monies into youth services, the Youth Coalition notes that there is still work to be done to make sure that the services provided with these funds support those most in need.

Other funding initiatives announced in the 2013 / 14 ACT Budget relating to youth services included:

- Continuation of the Fourth Unit at Bimberi Youth Justice Centre
- Development of an Out of Home Care Strategy
- Children and Young People Death Review Committee
- DisabilityCare – Additional Support for Post-school Options

The Youth Coalition welcomes the range of initiatives in the budget supporting vulnerable young people. It is noted this expenditure is coupled with a number of savings that have been made in expenditure over the coming financial year, including cuts to some programs previously supporting vulnerable young people.

Education

The Youth Coalition submission to the 2013 / 14 ACT Budget called on the ACT Government to: provide full support to the recommendations of the Gonski Review; increase support for preventative and frontline health, mental health and social support programs in schools; improve transitional supports and education pathways for multicultural young people; and, support programs targeting improved educational outcomes for Aboriginal and Torres Strait Islander young people.

The Youth Coalition applauds the ACT Government for signing on to the National Plan for School Improvement (Gonski) and notes the following 2013 / 14 Budget initiatives to support this:

- ACT Base Funding Adjustment – National Schools Reform
- Savings Reinvestment to Transition to Gonski

Other welcome funding initiatives announced in the 2013 / 14 ACT Budget in Education and Training included:

- Secondary Bursary Scheme
- Special Needs Transport
- Canberra College Cares – New Building at Phillip Campus

The Youth Coalition notes that the details of how the roll out of Gonski reforms in the ACT will affect supports to students experiencing disadvantage and/or at risk of disengaging from education is still to be announced. It is also noted that with the cutting of the Youth Connection Program from the Community Services Directorate the expectation is that Education and Training will support young people who are at risk of disengaging from education as a part of their core business.

Housing and Homelessness

The Youth Coalition submission to the 2013 / 14 ACT Budget included a call for the ACT Government to address housing affordability, particularly for young people. While the Budget outlines some measures to address housing affordability in Canberra such as changes to the land rent scheme and continuing reforms to stamp duty, the Youth Coalition argues more work needs to be done by the ACT Government in this area.

Funding initiatives announced in the 2013 / 14 ACT Budget related to Housing and Homelessness included:

- National Partnership Agreement (NPA) on Homelessness Extension
- Housing and Homelessness Advocacy and Policy Services
- Common Ground Supportive Housing

The Youth Coalition welcomes the commitment to the NPA for a further 12 months, part of the funding for housing and homelessness advocacy committed to in the Parliamentary Agreement. Capital works investment in developing the Common Ground model is also welcome, noting that this is not a youth specific service.

Health and Wellbeing

The Youth Coalition submission to the 2013 / 14 ACT Budget included calling for greater training for frontline healthcare workers to target services to young people, early intervention, outreach and therapeutic mental health services; mental health education provision; and, support to the establishment of a Sobering Up Service Trial for young people aged 16 and 17 years.

Funding initiatives announced in the 2013 / 14 ACT Budget related to Health and Wellbeing included:

- Establish an Outpatient Service for Drug and Alcohol Services
- Enhanced Belconnen Health Centre and Walk-in Centre
- Growth in Community Mental Health Services
- Mobile Dental Clinic

The Youth Coalition welcomes these investments and believes they have the potential to have a significant impact on young people's physical and mental health, social development, educational achievement and contact with the criminal justice system.

While these services are not youth specific the Youth Coalition acknowledges that young people will benefit, particularly if services take steps to ensure they target services to young people and provide more youth-friendly practice.

Young People and the Law

The Youth Coalition submission to the 2013 / 14 ACT Budget identified targeted funding for legal education programs; expansion of programs directed at preventing young people entering incarceration; and additional resources to implement the key actions of the ACT Blueprint for Youth Justice, as some of the key priorities in the area of young people and the law.

Funding initiatives announced in the 2013 / 14 ACT Budget included:

- Fourth Unit at Bimberi Youth Justice Centre
- Community Legal Centres (CLCs) Hub Accommodation
- Official Visitor Scheme
- Alcohol Interlocks

The Youth Coalition welcomes the investment in hub accommodation for CLCs, and the expansion of the Official Visitor Scheme, in particular the appointment of Aboriginal and Torres Strait Islander Official Visitors.

The Youth Coalition also strongly supports the introduction of interlocks for all ACT drivers convicted or found guilty of high range or repeated drink-driving offences.

Transport and Planning

The Youth Coalition submission to the 2013 / 14 ACT Budget called on the ACT Government to develop public transport networks to address the needs of young people and to recognise the ACT Government's commitment to becoming a 'Child and Youth Friendly City' with the provision of public space and transport options.

Funding initiatives announced in the 2013 / 14 ACT Budget related to Transport and Planning included:

- Transport for Canberra – Public Transport Improvements, Bus Stop Upgrades to Disability Standards, and Walking and Cycling Infrastructure
- Woden Bus Interchange Redevelopment (Finalisation of Design)

Further, a number of initiatives investing funding in sporting facilities were announced. The Youth Coalition welcomes these and acknowledges that sport plays a prominent role in the lives of young people. Young people in the 'Rate Canberra' 2012 survey identified sport as one of the top three organised activities participated in.ⁱⁱ

Budget initiatives such as fare discounts (public transport improvements), bus upgrades to meet disability standards investment into walking and cycling infrastructure are also welcome, however further investment in public transport and city planning is required to realise the commitment to becoming a 'Child and Youth Friendly City'.

Workforce Development

The Youth Coalition submission to the 2013 / 14 ACT Budget called for investment in the youth and community sector workforce, recognising the value of multi disciplinary approaches, and the role of youth workers in engaging and supporting young people.

The youth sector in the ACT is both diverse and unique in its composition and delivery of services to young people aged 12 – 25 years and their families. It has strong linkages with a range of other sectors in the ACT, including (but not limited to): housing and homelessness, mental health, alcohol and other drugs, education, employment, justice, family support, disability, health, arts and recreation, out-of-home care, and the broader community sector.

While there was no specific commitment to broad youth sector workforce development, the Youth Coalition recognises the commitment under the Children, Youth and Family Services Program Framework to workforce development and will continue to work closely with the ACT Government regarding ongoing implementation of these resources.

Funding announced in the 2013 / 14 ACT Budget did include an initiative to support teachers:

- Investing in Teachers

The Youth Coalition welcomes investment in teacher professional development but calls on the ACT Government to also meet the commitment under the Parliamentary Agreement to progressively expand student assistant services, including social workers, teachers, and school counsellors.

Community Sector

The Youth Coalition submission to the 2013 / 14 ACT Budget also highlighted the need for investment in and support to the community sector that recognises the change in demand for services, and addresses unmet need.

The Youth Coalition acknowledges further investment in some areas of community sector services, such as mental health services, and youth engagement, however overall the community sector will see further tightening of budgets for services.

For example, while the ACT Government has continued the allocation of funding to support pay raises for staff covered by the Fair Work Australia Award Equal Remuneration Order, it is noted that the Community Sector Indexation Rate is 2.85%, which when adjusted with the 0.34% ACT Community Sector Reform initiative works out to be 2.51%. Given inflation and the increase in superannuation percentage from July 1 2014, this means that many of the services who would normally pass on some indexation to staff through wages may not be in a position to do so this year.

ACT Budget: Much Detail Still to Come

The Youth Coalition of the ACT, the peak body for youth affairs and young people aged 12 – 25, is pleased to see some spending in services for young people announced in today's ACT Budget, but notes that much of the detail is still to be worked out.

'We were pleased that the ACT Government's election commitment to additional funding for youth engagement services has been realised', said Emma Robertson, Youth Coalition Director.

'This follows campaigning from both young people and the youth sector to ensure that youth services are resourced adequately and available to young people and their families across the Territory'.

The funding committed under *Youth Engagement and Family Support for Youth* of \$1.13 million in 2013/14 (\$4.93 mill over the next 4 years) has been identified to support the following:

- Existing Youth Engagement Services under the Children Youth and Family Services Program;
- Funding for a community based transitions worker; and,
- Diversity ACT

While it is great to see this injection of monies, the Youth Coalition notes that there is still work to be done to make sure that the services provided with these funds support those most in need.

'It is essential to see this money bolster existing services, which have seen a reduction in funding over the past 18 months.' said Ms Robertson.

The Youth Coalition and Families ACT have commissioned a research project which examines the rationale for integrated service delivery for young people, articulates a range of promising models for young engagement, and identifies participation approaches for vulnerable young people.

'It is vital that services are developed in an informed way, utilising the evidence about what is needed and what works in providing key supports to young members of our community.'

General Comments:

The Youth Coalition welcomes the range of initiatives in the budget supporting vulnerable young people. It is noted this expenditure is coupled with a number of savings that have been made in expenditure over the coming financial year, including cuts to some programs previously supporting vulnerable young people.

Therapeutic services

The Youth Coalition's submission to the ACT Budget called for further investment in therapeutic services. While the Trauma Recovery and Research Centre is most welcome, the Youth Coalition notes this investment is in one service and we believe there still needs to be a range of other complementary community based therapeutic services.

Therapeutic services are an essential component of a service system that seeks to address the support needs of vulnerable young people and their families. The risk factors which contribute to increased vulnerability and require a therapeutic response include; family breakdown, intergenerational trauma, sexual abuse, family violence, neglect, family drug and alcohol use, and a history of failure of support systems.

Respectful relationships

The Youth Coalition's submission to the ACT Budget called for on-going investment in the delivery and evaluation of respectful relationships programs for young people in schools and other settings. Stakeholders identified this critical area of early intervention and prevention during consultation as a key strategy to eliminate violence against women in the ACT community. This remains an outstanding issue.

Youth Justice

While the fourth unit at Bimberi is welcome, the Youth Coalition is concerned there are no additional initiatives outlined to implement the ACT Blueprint for Youth Justice. It is noted some funds have been rolled over from the previous year. (See also comments on Justice Reinvestment under JACS)

General Comments:

Investment in Education and Gonski

The Youth Coalition recognises that Education is a major investment of the ACT Government each year. This investment is important, as low education attainment rates have been linked to many negative outcomes, from mental health issues to cardiovascular disease.¹ The Youth Coalition supports the provision of funding to the Gonski reforms with a view that it will boost educational attainment rates by targeting extra funding for those students most in need of support. The full implementation of Gonski is expected to provide particular funding for students with disabilities, Aboriginal and Torres Strait Islander students, low Socioeconomic Status (SES) students and students with English as a Second Language. The Youth Coalition expects that the full implementation of Gonski reforms will include provision for the items of recommendation 6 in the Youth Coalition's 2013/2014 ACT Budget Submission, specifically a two-tiered model of funding; and, funding for schools to address disadvantage.

Integrated preventative and frontline health provision in schools

The Youth Coalition's submission to the budget called for increased support for preventative and frontline health, mental health and social support programs in schools such as the work undertaken by: school nurses; school based youth workers; and, pastoral care teams. This remains an outstanding issue. Schools are recognised as a first to know agency regarding many aspects of young people's lives. The co-location of services such as health professionals, youth workers, social workers and psychologists within schools has the potential for more efficient and effective service delivery. Further, provision of these services within schools makes them more accessible for young people and their families. In order to be supportive of the general health needs of young people, teaching staff require ongoing professional development to identify and respond to issues that may arise.

Programs targeting support and improved educational outcomes for Aboriginal and Torres Strait Islander young people

The Youth Coalition's submission to the ACT Budget called for the ACT Government to provide resources for existing and new successful programs targeting support and improved educational outcomes for Aboriginal and Torres Strait Islander young people. This remains an outstanding issue. The Youth Coalition is concerned that there remains a significant gap in retention rates and educational attainment between Aboriginal and Torres Strait Islander people and the rest of the population. Those who are less engaged in education have costly outcomes for their health, employment and housing prospects. These issues are closely interlinked and such links suggest that investment in any of the associated areas means better outcomes in the other. The Youth Coalition notes that there were no specific new funding initiatives for closing the gap between Aboriginal and Torres Strait Islander students and students from the rest of the population in the 2013/2014 ACT Budget.

Respectful Relationships Program

The Youth Coalition's submission to the ACT Budget called for on-going investment in the delivery and evaluation of respectful relationships programs for young people in schools and other settings. Stakeholders identified this critical area of early intervention and prevention during consultation as a key strategy to eliminate violence against women in the ACT community. This remains an outstanding issue

Transitional Supports and Education Pathways for Multicultural Young People in the ACT

The Youth Coalition's submission to the ACT Budget called for the ACT Government to improve transitional supports and education pathways for multicultural young people in the ACT, including newly arrived or refugee young people who are too young or too old to access current programs. While there has been funding for a new Introductory English Centre in Tuggeranong this initiative is for primary school students. The Youth Coalition identified that there are particular issues for those who are newly arrived or from a refugee background who may have experienced limited formal schooling, or gaps in their education. Services that work with young people from CALD backgrounds have highlighted the need to provide additional resources to English as a Second Language (ESL) programs. These services report that young people who are under the age of 16, and who are not eligible to participate in the Dickson College Program, often experience a range of challenges in maintaining attendance at school. Further, young people are in particular need of additional support when making transitions between schools, including from intensive English centres to mainstream high schools. If not supported during these transitions, students risk become disengaged from education before they reach the age that they could access support.

General Comments:

Transport

Young people frequently identify limited transport accessibility in the ACT as a barrier to employment, education, and recreational activities, in addition to the lack of affordable housing options in the Territory.

Additionally, the Youth Coalition advocates for the immediate investment in affordable, safe and reliable public transport to allow young people maximum access to employment and education.

Affordable Housing

While this budget outlines some measures to address housing affordability in Canberra, the Youth Coalition argues that more work needs to be done by the ACT Government to provide immediate affordable housing options that allow young people to rent privately. In coming years, we urge Government to allocate more funding for affordable housing initiatives for young people.

General Comments:

Training for healthcare workers

The Youth Coalition's submission to the ACT Budget called for the ACT Government to allocate funding to support greater training and support for frontline healthcare workers such as GP's and psychologists to target their services to young people and provide more youth-friendly practice within these services. This remains an outstanding issue. The Youth Coalition encourages such training and professional development to be included in all health initiatives.

Early intervention, outreach and therapeutic mental health services

The Youth Coalition's submission to the ACT Budget called for an increase in investment in early intervention, outreach and therapeutic mental health services for young people and their families. The Youth Coalition welcomes growth in Community Mental Health Services, and the inclusion of mental health services in the Belconnen Health Centre. We encourage work to ensure these services are fully equipped to respond to young people's particular circumstances and needs, and the needs of their families. The Youth Coalition strongly supports early intervention services as such programs have been shown to be effective and efficient in improving outcomes for young people and preventing costly and disruptive interventions such as hospitalisations.

Mental Health Education

The Youth Coalition's submission to the budget called for an increase in mental health education provision targeting young people in schools and other locations, families, and teachers. This remains an outstanding issue. Friends, family and teachers are often at the frontline of supporting young people experiencing mental health issues. Young people identify friends, family and the Internet as the top three places they go to for information and support regarding mental health and wellbeing. This suggests mental health education, such as Mental Health First Aid training or Mental Illness Education ACT (MIEACT) programs, need to be provided to these groups to help identify issues in the early stages and provide information about available services and supports. The Youth Coalition believes mental health education promotes quality help seeking behaviour.

Sobering Up Shelter

Finally, the Youth Coalition's budget submission called for support to establish a Sobering Up Shelter Trial for young people aged 16 and 17 years. This remains an outstanding issue. The Youth Coalition understands this trial is likely to be undertaken by CatholicCare within their existing budget. However, given the prevalence of alcohol use and associated harms amongst this age group, this project may require additional funding in the future. While ACT Policing currently have the option to transport intoxicated people over the age of 18 years to a sobering up facility, this is not available as a response for young people under the age of 18. As such, intoxicated young people may experience inappropriate responses, such as being detained in the Regional Watch House, and engagement with the criminal justice system

General Comments:

Housing affordability

The private rental market in the ACT is amongst the highest in Australia. Many young people report difficulty in gaining entry to private rental properties, due to cost, availability and discrimination.

The Youth Coalition recommends a 30% increase in rent assistance for young people on Newstart Allowance or Youth Allowance and a review of payments taking into account jurisdictional issues. The ACT Government is urged to lobby the Commonwealth Government on this issue and consider supplementary payments to ACT residents on CRA in severe housing stress.

While this budget outlines some measures to address housing affordability in Canberra (eg. changes to the land rent scheme and continuing reforms to stamp duty) the Youth Coalition argues more work needs to be done by the ACT Government in the area of housing affordability, and supporting young people to rent privately. In coming years the ACT Government is urged to allocate more funding to affordable housing initiatives for young people.

The Youth Coalition notes the Chief Minister and Treasury initiative promoting Canberra as a study destination of choice. It is essential students have a range of affordable housing options when they choose to study in Canberra.

Homelessness

Homelessness services in the ACT are facing significant cuts over the next three years. The Youth Coalition welcomes the ACT Government's commitment to find resources to decrease projected shortfall in funding for homelessness support from \$5.9million to \$3.6million. This withdrawal of funding is of particular concern in an environment where there is already significant unmet need and increasing demand. As the youth homelessness sector has already undergone significant reform, the ACT Government is urged not to consider further funding cuts in this sector in coming years as services are already stretched and unable to meet demand. Significant gaps in the existing system have been identified such as a lack of services designed to work with young people experiencing high and complex needs. Many youth homelessness support services are also reporting that current funding does not adequately cover the cost of service delivery, thereby limiting capacity to deliver quality services and desired outcomes.

Additionally, the Youth Coalition also welcomes the Minister for Housing's recent announcement that the current reform process will include an evaluation in 2014. With any reform process it is essential an evaluation framework is built in to ensure the aims of the reform are being achieved, the full cost of service delivery has been granted, and to highlight any unforeseen service gaps which may have resulted from the reform.

Justice Reinvestment

The Youth Coalition is disappointed that there are no new initiatives that:

- Provide early intervention to prevent young people entering incarceration;
- Provide funding to pilot and evaluate Justice Reinvestment Models

The Youth Coalition's submission to the budget called for Justice Reinvestment models to be explored, piloted and evaluated in the ACT with the aim to address underlying causes of offending and called for programs directed at preventing young people entering, and removing young people from, incarceration, in line with best practice. The Youth Coalition would encourage a greater focus on early intervention and prevention including the piloting of Justice Reinvestment models and the adoption of the key actions of the ACT Blueprint for Youth Justice. In addition, whilst the Youth Justice Blueprint is the responsibility of the Community Services Directorate, the Youth Coalition would urge JACS and CSD to work together to realise the key actions of the Blueprint.

Legal Education Programs

The Youth Coalition's submission to the budget called for targeted funding for legal education programs directed at informing young people of their rights in order to empower them to prevent breaches. Legal Education empowers young people to protect their legal rights; advocate for themselves in regard to legal issues; avoid behaviours and actions that have been deemed criminal and avoid coming into contact with the legal system.

Human Rights

The Youth Coalition's submission to the budget called for biannual reviews of Human Rights compliance at Bimberi Youth Justice Centre. While the Youth Coalition acknowledges and welcomes the continuation and expansion of the Official Visitor Scheme, ongoing review and monitoring of human rights compliance provides valuable information about how the overall system could be improved and is vital in order to develop the most effective whole of government youth justice response.

Aboriginal Legal Services

The Parliamentary Agreement included a promise of \$100, 000 for Aboriginal Legal Services. This investment was not made in the 2013 / 14 Budget. The Youth Coalition would support further investment into Aboriginal Legal Services, noting the overrepresentation of Aboriginal and Torres Strait Islander people in the justice system.

General Comments:

Transport

The Youth Coalition's submission to the budget called for the development for public transport networks that address the needs of young people, are accessible and affordable, and include adequate evening, late night and weekend services. This remains an outstanding issue. Access to affordable, safe and reliable public transport is essential to participate economically and a key socio-economic determinant of health and wellbeing for young people. While the Youth Coalition acknowledges budget initiatives such as the fare discounts and bus upgrades to meet disability standards, further investment in improving public transport is urgently required.

Planning

The Youth Coalition's submission to the budget called for the ACT Government to realise its commitment to becoming a 'Child and Youth Friendly City'. This remains an outstanding issue. While, the Youth Coalition welcomes the continued investment into walking and cycling infrastructure, further investment in city planning is required to create a youth friendly city. Public space plays an important role in the lives of young people. The Youth Coalition seeks clarification on how the ACT Government plans to provide youth friendly spaces.
