PRIVATE MEMBERS' BUSINESS

Notices

- *1 **MS CASTLEY:** To move—That this Assembly:
- (1) notes:
 - (a) ACT Government expenditure on health grew at 3.3 percent per year between 2012 and 2019, which is significantly less than rising health costs and wages over the same period; and
 - (b) Commonwealth Government funding to the ACT for health grew at 9.2 percent per year over the same timeframe;
 - (2) further notes the Labor/Greens Government:
 - (a) cut real expenditure on health per person by 3.6 percent between 2015-16 and 2018-19;
 - (b) reduced available beds against the 2011 Capital Asset Plan by 150 beds between 2015-16 and 2020-21;
 - (c) will decrease staff across Canberra Health Services and ACT Health next year by 124 full-time equivalent; and
 - (d) has overseen the worst emergency department wait times in the country since 2017-18 according to the Productivity Commission's Report on Government Services;
 - (3) acknowledges the Commonwealth Labor Government:
 - (a) has reduced public hospital funding by \$775.4 million in 2022-23; and
 - (b) will cut \$2.4 billion in funding to public hospitals over the next four years; and
 - (4) calls on the ACT Government to:
 - (a) report to the Assembly by the end of the first sitting week of 2023 about why it has cut health funding since 2015-16;
 - (b) reverse their real cuts to health funding;
 - (c) write to the Federal health minister requesting a reversal of the Commonwealth's proposed cuts to public hospital funding; and
 - (d) table the letter to the Federal health minister in the Assembly by the end of the first sitting week of 2023. *(Notice given 28 November 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A).*

*2 **MS LEE:** To move—That this Assembly:

- (1) notes that:
 - (a) the ACT Council of Social Service, in its 2022 ACT Cost of Living Report, shows that over the past five years Canberra has experienced significant price increases for essential goods and services, including:
 - (i) transport up 19.2 percent;
 - (ii) electricity up 28.1 percent;
 - (iii) gas up 24 percent;
 - (iv) medical and hospital services up 21.4 percent;
 - (v) housing up 19.0 percent;
 - (vi) rents up 13.1 percent; and
 - (vii) education up 17.0 percent;
 - (b) in addition to these significant price increases for essential goods and services, inflation in Canberra is at levels we've not seen since the 1900s;
 - (c) over the last 10 years, household rates have increased by an average of 10 percent, and will continue to rise;
 - (d) the median house price in the ACT remains close to \$1 million;
 - (e) successive interest rate rises are adding an extra \$1,000 per month to the average mortgage, with more expected rate rises to come;
 - (f) the cost of renting a typical house is now \$750 per week – the highest for any capital city in the country;
 - (g) the cost of childcare is the highest in the country; and
 - (h) general practice bulk billing rates are the lowest in the country; and
- (2) calls on the ACT Labor/Greens Government to:
 - (a) recognise that many Canberran's are facing a real cost-of-living crisis; and
 - (b) report back to the Assembly by Thursday 30 March 2023, on the drivers of the cost-of-living pressures in Canberra and measures available to the ACT Labor and Greens Government to address these pressures. *(Notice given 28 November 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A).*

*3 **MS ORR:** To move—That this Assembly:

- (1) notes that:
 - (a) autoimmune disorders affect an estimated five percent of the Australian population and they are often chronic and with many associated impacts;
 - (b) there are around 80 different autoimmune disorders;

- (c) the effects of different disorders can range from mild to highly impactful on day-to-day life;
 - (d) diagnosis of autoimmune disorders can often take years for a large proportion of those who are impacted by them;
 - (e) for unknown reasons women are more likely than men to develop an autoimmune disorder;
 - (f) there is no known cure for most autoimmune disorders, but symptoms can usually be managed through various treatments, providing varying levels of relief;
 - (g) there are some small awareness and advocacy groups for autoimmune disorders in Australia, however, there is currently no large peak body representing those who experience autoimmune disorders;
 - (h) while there is ongoing research into autoimmune disorders, they are relatively poorly understood and there is a lot of research to be done; and
 - (i) in other jurisdictions awareness of autoimmune disorders is raised through community awareness activities such as Autoimmune Awareness Month in the USA; and
- (2) calls on the ACT Government to:
- (a) consider potential options to raise awareness of autoimmune disorders within the ACT community; and
 - (b) report back to the Assembly on the options identified by the last sitting day in 2023. (*Notice given 28 November 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A*).

*4 **MR PARTON:** To move—That this Assembly:

- (1) notes:
- (a) the Government ignored its own 2016 travel survey which indicated that the majority of Canberrans wanted direct buses to the city by redirecting most of those services to terminate at the tramline;
 - (b) prior to the commencement of Stage 1 of the tram, it was possible to get on a direct bus from every suburb in Gungahlin to Civic, except for the suburbs that weren't actually populated at that stage;
 - (c) on the commencement of tram services, Gungahlin lost the:
 - (i) 200 Red Rapid bus;
 - (ii) 202 Express bus from Gungahlin to the city;
 - (iii) 251, 252, 254, 255 and 259 Xpresso routes from Gungahlin suburbs to the city;
 - (iv) 56 service from Palmerston;
 - (v) 57 service from Franklin; and
 - (vi) 58 service from Harrison; and

- (d) that services from the inner north and Belconnen that went to the city were redirected to the Dickson interchange, namely the 30 and 31 services from Kaleen and Giralang and the 39 service from Watson was changed so drastically that it ceased being a viable option for commuters;
- (2) further recognises:
 - (a) once the Stage 1 tram was opened, the travel time to Civic from many suburbs that once had direct buses routes increased;
 - (b) since Light Rail Stage 1 services commenced, the percentage of Canberrans as a proportion of the growing population, that use public transport has not increased, even before COVID hit; and
 - (c) there are currently many southside suburbs that have direct routes to Civic; and
- (3) calls on the ACT Government to guarantee that:
 - (a) direct bus routes from suburbs south of Lake Burley Griffin to Civic will be protected, will be maintained and not cancelled when the Woden tram commences, and that commuters will not be forced onto the tram; and
 - (b) the public transport travel time from any suburb south of Lake Burley Griffin to Civic will not increase compared to the time it takes today, and doing this by keeping the direct bus routes as is, once the tram to Woden commences. *(Notice given 28 November 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A)*

*5 **MR BRADDOCK:** To move—That this Assembly:

- (1) notes:
 - (a) in Australia, one in three drowning deaths occur in rivers and creeks;
 - (b) drowning deaths have increased 15 percent from 2021 to 2022 and have increased 24 percent over the past 10 years; and
 - (c) the summer months of December and January are peak months for drowning deaths in Australia;
- (2) further notes:
 - (a) migrants are at a far higher risk of drowning when compared to the general population;
 - (b) following the drowning death of beloved local Afghan man Najeeb Rafee in 2019, community groups like the Refugee and Migrant Swimming Project have been calling for the ACT Government to improve safety measures at inland waterways; and
 - (c) the Royal Life Saving Society is currently producing a report on safety equipment across Canberra's river-based swimming spots; and

- (3) calls on the Government to:
 - (a) within six months of the date of the Royal Life Saving Society report, publish a plan to address risks arising from identified safety equipment shortages at ACT inland swimming spots, including emergency phones where there is no reception;
 - (b) review signage and safety information at popular inland swimming spots to ensure it is accessible and clear;
 - (c) provide greater public education about swim safety that is accessible in a variety of languages; and
 - (d) report back to the Assembly by the last sitting day of November 2023 on progress. *(Notice given 28 November 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A).*

*6 **MR PETTERSSON:** To move—That this Assembly:

- (1) notes that:
 - (a) mental ill health in childhood and adolescence can have substantial impacts on wellbeing and productivity. These impacts are exacerbated for young people in high-risk groups such as those affected by violence, abuse, maltreatment, or poverty;
 - (b) the Australian Bureau of Statistics' National Study of Mental Health and Wellbeing found that almost two in five people (39.6 percent) aged 16-24 years had a 12-month mental disorder in 2020-21. Split by gender, almost half (46.6 percent) of females aged 16-24 years and almost one third (31.2 percent) of males aged 16-24 years had a 12-month mental disorder;
 - (c) as reported in the 2021 Census, 35.3 percent of Gungahlin's population are young people below 24 years of age; and
 - (d) supported by strong prevention and early intervention measures, young people can be empowered to manage their mental health and lead a psychologically healthy life;
- (2) further notes:
 - (a) headspace provides services to young people aged 12-25 years at two locations in the ACT, namely Tuggeranong and Canberra city;
 - (b) at headspace, young people can access mental health services, sexual health services, work and study services, alcohol and drug services, and general practitioner doctor services; and
 - (c) young people located in the ACT's northern-most suburbs face significant barriers if they need to access headspace's services at the Canberra city location;
- (3) acknowledges:
 - (a) the ACT Government is committed to supporting people living with a mental illness or mental disorder, and their families, friends, carers, and service providers;

- (b) the ACT Government's rollout of the online youth navigation portal, Mind Map, that supports young people find the care they need across the mental health system;
 - (c) the 2022-23 Budget includes an additional \$70 million over four years for mental health and community health care support, building on over \$40 million already provided to support mental health since May 2020, including new funding for youth measures:
 - (i) \$8.1 million over four years to expand mental health supports for youth and young adults to address priority needs of young people who are experiencing or are at risk of mental health concerns and/or suicide and self-harm;
 - (ii) expanding the Childhood Early Intervention Team to Gungahlin Child and Family Centre;
 - (iii) the impending inauguration of the adolescent mental health ward at Canberra Hospital;
 - (iv) grants for initiatives to support vulnerable or disadvantaged children to participate in sport and recreational activities that improve their physical wellbeing, health, and social skills;
 - (v) ongoing redevelopment of the Watson Health Precinct that will deliver a new purpose built facility for Catholic Care's STEPS voluntary mental health residential program for 13-18 years old; and
 - (vi) establishing new eating disorder programs and services, including STRIDE, a parent support program, and clinical hub for eating disorder services, as well as progressing work towards establishing an early intervention service for eating disorders and construction of the ACT's first eating disorder residential centre; and
 - (d) the ACT Government's investment in Orygen's digital mental health care platform MOST, which provides young people aged 12-25 with access to online therapy, tools, and programs; and
- (4) calls on the ACT Government to:
- (a) provide an update on the timeline for implementation of Orygen's MOST platform in the ACT;
 - (b) advocate for the Federal Government to fund a headspace located in Gungahlin;
 - (c) provide an analysis of how the ACT Mental Health Workforce Strategy aligns with the National Mental Health Workforce Strategy and compares to other jurisdictions, including intended outcomes for peer support workers;

- (d) provide an update to the Assembly on the implementation of the Position Statement on Youth Mental Health Recovery from COVID-19 and advise how youth mental health in this post-lockdown period is responding;
- (e) provide suitable social and recreational spaces for young people in Gungahlin where they can develop their physical, social, emotional, and cognitive abilities;
- (f) provide an update on mental health supports being considered for young Canberrans that could contribute to reduced wait lists and duration of treatment for mild to moderate mental health conditions and the Missing Middle; and
- (g) report back to the Assembly no later than the first sitting week of May 2023. *(Notice given 28 November 2022. Notice will be removed from the Notice Paper unless called on within 4 sitting weeks – standing order 125A).*

*7 **MR MILLIGAN:** To move—That this Assembly:

- (1) notes that:
 - (a) since 2020, the Government has promised to increase the number of serving ambulance officers to meet the increasing demand;
 - (b) on 4 August 2022, Mr Gentleman told the Assembly that previous funding packages had delivered 53 new paramedics; and
 - (c) annual reports from the previous years show that the number of serving ambulance officers has increased by only five this last financial year, and only 18 the financial year previously, which is a total of only 23 paramedics;
- (2) further notes that:
 - (a) annual reports show that demand has increased by 11 percent over the last year;
 - (b) this year has seen a significant shortage of paramedics such that fire crews have had to be deployed to meet demand;
 - (c) major issues for the paramedics present at the meeting include long night shifts, with paramedic rosters scheduling workers on back-to-back night shifts of 14 hours long per night;
 - (d) according to the Transport Workers' Union spokesperson, the one ComCen program has lagged for seven years and delivered nothing other than a change in uniforms; and
 - (e) on Friday 25 November, paramedics unanimously passed a motion of want of confidence in the leadership of the Emergency Services Agency; and
- (3) calls on the Minister for Police and Emergency Services to:
 - (a) detail to the Assembly all actions he is taking to address the issues raised by the ambulance officers; and

- (b) report back in the first sitting day of 2023 with a progress report.
