RESPONSE TO QUESTION TAKEN ON NOTICE Inquiry into Petition 32-21 (No Rights Without Remedy) 28 April 2022

DR PATERSON: Do you have any data or anything on the level of complaints that do come through that do have a human rights element?

Mr Gaughan: We do not have that, but we can definitely get that. Our professional standards area will have that. Certainly in the last—we do get a quarterly update—

Mr Whowell: We do.

Mr Gaughan: —from professional standards and we have received that just recently. I do not recall any being in it. And it is the sort of thing that would, obviously, raise alarm. But we will come back to the committee with that data. We should be able to get that pretty quickly.

Mr Whowell: Yes, because the categories of misconduct are an instrument between the Ombudsman and ourselves, which sets out count 1, 2, 3 and 4 and that sort of talks about the behaviours, so that may well be—

THE CHAIR: Yes, and that is the Commonwealth Ombudsman?

Mr Gaughan: Correct.

MR GENTLEMAN MLA - The answer to the Member's question is as follows:

All data for this report has been sourced from the SAS reporting suite.

This report is reflective of PRS Matters (submitted and finalised) relating to ACT Policing from 1 July 2018 to Financial Year to Date (FYTD) 2021/2022 (9 May 2022).

The data is current as at 9 May 2022 and is subject to change as complaints are upgraded, downgraded, deleted or merged. Finalised Complaints figures may include complaints submitted in a previous financial year.

A keyword search was used to identify all complaints that include one or more of the following terms in the description:

- Human Rights
- Human Right
- Breach of Human Rights
- Breach of Human Right
- Human Rights Breach
- Human Right Breach

From 1 July 2018 to 9 May 2022 (2021/2022 FYTD), the keyword search identified four (4) complaints that were submitted to AFP Professional Standards involving 11 alleged human rights breaches.
