Mum advised P01 she had already contacted Police and the youth crisis centre and will be seeking support of P01. P01 advised herself and her husband were very distraught as their daughter P01 had, through play with dinosaurs, disclosed that 'the man had shown her penis videos'. P01 stated that P01 only attends Urban Education and receives care from her grandmother... why would her daughter say video? P01 asked what the police had advised and was told the police referred P01 to speak directly with the service. P01 questioned P01's care arrangements prior to coming to Urban, perhaps the incident had been prior to her enrolment. P01 discussed the support options available and highlighted risks by asking children leading questions. P01 advised she would find out who the educators were working in P01's room at other service. P01 advised against this referring her to appropriate services that can help in these instances. *Please see attached evidence to elaborate on above and correspondence.
